Hi Raj,

Thank you for those examples. Actually I did a search with four key words (futures, options, swaps, hedging) for 2001 to 2002 and was very impressed as I read through the extracts of what the search turned up. I have a colleague that spent a year with 2 colleagues at UT@Austin trying to produce this type of information. Further, I plan to show two other colleagues that are trying to search for certain types of contracts. So, I can clearly see this system's potential.

However, I did not see how to save the search list nor the extracts and those are some of the things that I wanted to ask about when we talk. Moreover, I was not clear if it was possible to submit a list of specific firm reports to search. Hopefully we can discuss these questions. 


- Next, one can get the going concern opinions by audit firms by re-searching the going concern opinions with audit firm names. This can be achieved in few seconds.
 - Keep the same search criteria as the previous case but type the words opinion Deloitte in Proximity Search with 350 words apart to get the going concern opinions issued by Deloitte.
 - Copy the CIK codes from the previous search output of all the companies that obtained GCO and paste it in slot for "COMPANY" and select CIK from the box on the right.
 - 3. Select the year, all 10Ks, and submit.


Percentage of Going Concern Opinions (GCOs) by Year

Example 4: Exact Phrases: We may never become profitable

- Did you know that there are public companies that make statements in their annual reports (10Ks) that they were not profitable and may never be profitable and still investors invest money?
- Why is that?
- How would you find out who they are? Manually it is impossible!
- Well, Seek iNF can answer this question in seconds.


Example 4: Exact Phrases: We may never become profitable

- Another interesting question comes to mind is what type of audit opinions were expressed by the corresponding auditors.
- You would expect all such companies should have received a Going Concern audit opinion.
- This is easy to find out using Seek iNF.
- Insert the following phrases "(We may never become profitable | We May Never Achieve or Sustain Profitability | we may never achieve or maintain profitability) along with the phrase for going concern opinion discussed earlier in the exact phrase slot and select "all companies", the time period, paragraph, and 10Ks, and get the result in seconds.

- Why is that? What about audit quality?
- Many interesting research questions emanate from this result.

By looking at several samples of executive compensation tables in DEF 14A for a pattern, and trying various different combinations of words and phrases, the two words 'salary' and 'bonus' within 2 words using **Proximity Search** got the result. Here are the detailed steps:

- Step 1: Type salary bonus in the Proximity Search slot separated by a space, and input 2 for how many words in between
- Step 2: Keep the default setting "All" in the COMPANY slot with the year 2015,
- Step 3: Select Table; Step 4: Select DEF 14A (Proxy statement)
- Step 5: Click on SUBMIT button



- The next slide is the screenshot of the display window and below the screenshot is the download of the results in Excel file.
- You need to submit a request similar to Example 6(a) to get the download of all the companies' result.
- As you can see from Examples 6(a) and 6(b), this feature can capture any financial or non-financial information with user's defined criteria.
- The best way to design this search would be to first look at few cases and identify the pattern the way information is presented in most of the filings and then design your search.

- The last six columns present the results, total word count with and without numbers along with counts of the phrases and words.
- This is a powerful tool for text analytics. You don't need to request anyone or learn any programming to get such data. The power is in your hands. You decide what phrases and words you want to count.
- Such data can be used to develop models for determining various kinds of risks (business risk, litigation risk, fraud risk, sentiments measures etc.)
- The key is to think of a problem before anyone else thinks.
- There is nothing in the market that can provide such data with so much ease.

Example 9: Competition Metric

Seekinf

Li, Lundholm, and Minnis developed "A Measure of Competition Based on 10-K Filings" which was published in *Journal of Accounting Research*, Vol. 51 No. 2 May 2013, pp: 399-436.

This paper computes management's perceptions of the intensity of the competition using textual analysis of the firm's 10-K filing. They count the number of occurrences of "competition, competitor, competitive, compete, competing," including those words with an "s" appended, and then remove any case where "not," "less," "few," or "limited" precedes the word by three or fewer words. Their measure of competition is

PCTCOMP = 1000*NCOMP/NWORDS,

where NCOMP = number of words in 10K as described above and NWORDS = Total number of words without numbers.

Seek iNF can help calculate PCTCOMP in no time.

- Suppose you want to measure PCTCOMP for the following five companies with CIK: 68622, 732712, 732717, 808461, 794323 (i.e., QWEST CORP, VERIZON COMMUNICATIONS INC, AT&T INC. LEVEL 3 COMMUNICATIONS INC, and GENERAL COMMUNICATION INC) from Telephone Communication industry, SIC = 4813, for the years 2006- 2015.
- You need to submit a "Request Form". The "Request Form" is listed in the top menu bar of Seek iNF. Since you can submit a request form only for a five year period, you need to divide the period 2006-2015 into two 5-year periods: 2006-2010, and 2011-2015.





- We have the entire subsidiary database available for all the companies for all the years from 1994 to 2016 with daily updates. Here is how one can access the database.
- After you have logged into the search engine, Seek iNF, select the menu item "10K-Exhibit (subsidiaries)" from the top menu bar. Next page, you will see a list of companies with all its subsidiaries by US and non US for various years. Here are examples of various searches you can perform on subsidiary database.

- 11(a). Find the US and Non US Subsidiaries for one company, a set of or all the companies by year. Follow these steps:
- Type in the name(s) or CIK code(s) in the slot "Company you would like to search for" and select 'name' or 'CIK' from the right hand side.
- Type the desired year in the slot "In the Year"
- Select "Display: Total number of US and non-US subsidiaries" and Submit.
- The system will display the list of subsidiaries for all the companies for the desired year. You can download the entire data in Excel by selecting "Export to Excel"

Example 12: Readability Indices for Satyam and WIPRO

For illustration, we consider two Indian IT companies, Satyam Computer Services Ltd, CIK = 1106056, and WIPRO Ltd., CK = 1123799, both filed 20-F with the SEC. In January 2009, Satyam's Chairman Ramalinga Raju sent a confession letter to SEBI (Securities and Exchange Board of India) admitting that he inflated the financial results and cooked books of Satyam. We would like to compare the readability indices of Satyam, a fraudulent company, with a competing good company, WIPRO Ltd. Here is what we need to do to get the readability indices for 20-F for the period 2002 to 2008.

Step 1: Type "a|the|of" without the quotes in the slot of "With the exact phrase". Or, you can use any search criteria including Boolean logic, if relevant for your search.

Step 2: Type either "Satyam Computer Services" and select option "Name" from the right or type the CIK code and select "CIK" option from the right. Select the time period 2002 – 2008. **Step 3:** Select "Paragraph (All)".

Step 4: Select 20-F and 20-F/A

Step 5: Submit

You will get the result in seconds. The next slide shows how you enter the above information and the following slide shows the output. Copy the right hand side panel containing the six readability indices and paste it in an Excel spreadsheet. This gives the data for 2008, as highlighted on the left side of the display panel. Check the second listing for 2007 from the left side panel. The system will show the readability indices on the right side. This time just copy the six readability indices without the labels and paste it in the previous Excel spreadsheet next to the 2008 numbers. Repeat this process until you have obtained the data for 2008-2002 (see 3rd slide).





You will get the result in seconds. The next slide shows how you enter the above information and the following slide shows the Cosine Similarity and Word Variation buttons at the top middle of the display window. Click on this button. The system will open another widow. Select the CIK that is already present (CIK of the company just searched) or type in another CIK that you want to get the compare data. Select the filing, in the present case 20-F, and the period 2002-2008 and then "Search". The system will list all the filings for your compare data. Now you select the specific year filings for the compare data or select all the years. In the present example, I will do it two at a time keeping 2003 year common. This is because I want to get Cosine Similarity measure relative to 2003 Filing. See the subsequent slides for details.




Example 13: Graph of Cosine Similarity Data for Satyam and WIPRO

Example 14: Word Variations Year-to-Year

- Let us consider an example of Enron. In order to get to the word variation, we need to get into the search engine by searching for any thing in our desired company. In the present case we will enter the company name Enron in the Exact Phrase slot and enter ENRON CORP in the company name slot, and select 1994-2023, paragraph, 10Ks and submit. Once you get the output, from the display window click on the link "Cosine Similarity/Word Variation". This will take you to the Cosine Similarity and Word Variation page. Select all the 10Ks for which you want the Word Variation.
- Next slide shows the sorted data for the years 1994 to 2001 for Enron.
- One can see that the following words: wholesale, broadband, and markets, were not used as frequently in the beginning years as they are being used in the recent years. Could this have been done intentionally? Well, this is a research questions.
- If one looks at the snippets related yo these words, one will realize that this may have been done to hype the market. See the slide following the word variation slide.

Example 15: Extract numbers (\$ or non \$ value) present in a line in Excel

This feature allows one to extract numbers from a line, whether they are in dollars or non-dollar values. This feature is especially useful when the information is presented in an unstructured way.

As an illustration we consider the following situation. Suppose you want to find the number of active patents disclosed by companies in their annual reports, 10Ks, filed with the SEC. Next few slides shows how you can obtain this information in an Excel file.

Example 15: Extract numbers (\$ or non \$ value) present in a line in Excel

Complete the following steps in the SeekiNF search page.

- Step1: Type the phrase active patents in the slot "With the exact phrase"
- Step 2: Since we are interested in all companies, we leave "All" the default choice, select the period, say one year period 1994 - 2019, and keep SIC(Optional) "All (SICs)"
- Step 3: Select Paragraph (All)
- Step 4: Select 10K (all 10Ks)
 - Step 5: Click on SUBMIT button

The system will display the snippets in the display window as shown in the next slide.

Note that for the numbers in dollar value, one needs to click on "Raw Dollar Values in CSV" as shown above in the top menu bar.

Next, one has to use human judgment to determine what number relates to what. In the current example, the text description in the column titled "Values" suggests that the number 14,000 relates to "active patents worldwide".



Use of Exact Phrases:



We generate revenue by developing, manufacturing, licensing, and supporting a wide range of software products and services for many different types of computing devices. Our software products and services include operating systems for servers, personal computers, and intelligent devices; server applications for distributed computing environments; information worker productivity applications; business solutions applications; high-performance computing applications; software development tools; and video games. We provide consulting and product support services, and we train and certify computer system integrators and developers. We also design and sell hardware including the Xbox 360 video game console, the Zune digital music and entertainment device, and peripherals. Online offerings and information are delivered through Live Search, Windows Live, Office Live, our MSN portals and channels, and the Microsoft Online Services platform which includes offerings for businesses such as Microsoft Dynamics CRM Online, Exchange Hosted Services, Exchange Online, and SharePoint Online. We enable the delivery of online advertising across our broad range of digital media properties and on Live Search through our proprietary adCenter® platform.								
L [Original]	Our revenue historically has fluctuated quarterly and has generally been the highest in the second quarter of our fiscal year due to corporate calendar year-end spending trends in our major markets and holiday season spending by consumers. Our Entertainment and Devices Division is particularly seasonal as its products are aimed at the consumer market and are in highest demand during the holiday shopping season. Typically, the Entertainment and Devices Division has generated over 40% of its yearly segment revenues in our second fiscal quarter. In fiscal year 2007, our revenue was highest in the third quarter due to the recognition of \$1.7 billion of revenue previously deferred from the Express Upgrade to Windows Vista and Microsoft Office Technology Guarantee programs and pre-shipments of Windows Vista and the 2007 Microsoft Office system. The technology guarantee programs provided customers who purchased current products with free or discounted rights to Windows Vista and the 2007 Microsoft Office system when those products became available to consumers. We intend to sustain the long-term growth of our businesses through technological innovation, engineering excellence, and a commitment to delivering high-quality products and services to customers and partners. Recognizing that one of our primary challenges is to help accelerate worldwide PC adoption and software upgrades, we continue to advance the functionality, security, and value of Windows operating systems and to develop operating system versions targeted at emerging markets. We also are increasing our focus on selling our products in emerging markets and reducing the amount of unlicensed software used in those markets. In addition, we continue to								

develop innovative software applications and solutions that we believe will enhance the productivity of information workers, improve communication and collaboration in work groups, aid business intelligence, and streamline processes for small and mid-sized businesses. To sustain the growth of our Server and Tools business amid competition from other vendors of proprietary and open source software, our goal is to deliver products that provide the best platform for network computing – software that is easiest to deploy and manage, and that is most secure – with the lowest total cost of ownership. We continue to invest in research and development in existing and new lines of business, including online solutions, business solutions, mobile computing,

communication, entertainment, and other areas that we believe may contribute to our long-term growth. We also invest in research and development of advanced technologies for future software products. We believe that delivering innovative and high-value solutions through our integrated platform is the key to meeting customer needs and to our future growth.

We believe that over the last few years we have laid a foundation for long-term growth by delivering innovative products, creating opportunities for partners, improving customer satisfaction with key audiences, and improving our internal business processes. Our focus in fiscal year 2009 is to continue to build on this foundation and to continue to execute well in key areas, including continuing to innovate on our integrated software platform, responding effectively to customer and partner needs, and continuing to focus internally on product excellence, business efficacy, and accountability across the company.
